



## **Covid-19 Addendum to Little Swans Day Nursery Policies and Procedures JUNE 2020**

It has also been informed by Guidance for Early Years Settings - COVID-19 Site Operating Procedures.

The information is relevant as of 18 May 2020. Should any changes in legislation or policy guidance have emerged since this date, these policy addendums may not fully reflect the changes. The nursery will continue to review the latest Covid-19 government guidance. The next government announcement is due on 28 May 2020 and parent / carers will be updated with any changes to policy/ practice accordingly.

The Government guidelines state that in childcare settings, providers will be asked to welcome back all children below statutory school age from the week commencing 1 June 2020. Within the guidance they anticipate that demand for childcare is likely to be lower than usual at first and existing space requirements, and staff to child ratios for these age groups, should allow for small group working.

Where the physical layout of a setting does not allow small groups of children to be kept at a safe distance apart, the Government expect practitioners to exercise judgement in ensuring the highest standards of safety are maintained. In some cases, it may be necessary for providers to introduce a temporary cap on numbers to ensure that nurseries can fully apply government guidelines and safety is prioritised.

<p data-bbox="224 790 548 893"><b>Absence / Sickness Management Procedure For staff Members</b></p>	<p data-bbox="604 395 1720 427"><b>The absence management policy remains in place with the additional requirements:</b></p> <p data-bbox="604 475 2027 622"><b>Exclusion periods:</b> any staff member with symptoms of coronavirus will be asked to follow government isolation guidelines (currently 7 days and/or if a family member has symptoms then they should isolate for 14 days.) These are available from <a href="https://111.nhs.uk/isolation-note/">https://111.nhs.uk/isolation-note/</a></p> <p data-bbox="604 790 2027 901">Staff should also not attend if they have symptoms, or are self-isolating, due to symptoms in their household. Staff should inform management immediately and if not already arranged a test for CO –VID 19 should be arranged</p> <p data-bbox="604 949 2027 1053"><b>Return to work:</b> all staff will be asked to complete a health declaration form on their return to work and after any episodes of illness to state that they are now fit and well, have no other symptoms and have isolated for the timescales set by the Government.</p> <p data-bbox="604 1101 2027 1284"><b>Staff who have been classed as clinically extremely vulnerable due to pre-existing medical conditions have been advised to shield:</b> we do not expect people in this category to be attending nursery, and they should continue to be supported by the furlough scheme or work at home (if this is at all possible) as much as possible. These cases will be discussed on a one-to-one basis with affected staff and clarification from a medical practitioner will be required.</p>

	<p><b>Staff that live in a household with someone who is extremely vulnerable:</b> where a staff member lives in a household with someone who is extremely clinically vulnerable, as set out in the <i>COVID-19: guidance on shielding and protecting people defined on medical grounds as extremely vulnerable guidance</i>; it is advised they only attend an education or childcare setting if stringent social distancing can be adhered to and, in the case of children, where they are able to understand and follow those instructions. This may not be possible for very young children and older children without the capacity to adhere to the instructions on social distancing. If stringent social distancing cannot be adhered to, we do not expect those individuals to attend. They should be supported by the furlough scheme or work at home (if this is at all possible). These cases will be discussed on a one to one basis with affected staff.</p> <p><b>Annual leave:</b> all annual leave including any not taken in holiday period 2019/20 will be documented in the usual way and discussed at supervisions as to when this can be taken, following government and HR guidelines.</p> <p><b>Coronavirus Job Retention Scheme (CJRS):</b> where applicable discussion will take place individually with staff that have been furloughed, about when they will return in line with the business needs.</p>
<b>Admissions</b>	<p><b><i>It is advised that settings develop their admissions policy/form and then ask parents sign up to this.</i></b></p> <p>Children who are symptom free or have completed the required isolation period, can attend nursery. Families are asked to inform nursery if they, the child or anyone in their household has any symptoms and to follow the</p>

	<p>COVID-19 guidance.</p> <p>Children that have been classed as clinically extremely vulnerable, due to pre-existing medical conditions, have been advised to shield and are not expected to return to nursery yet. We will continue to communicate with you as much as possible and share useful educational resources. This will be reviewed in line with government guidelines.</p> <p>We will provide parents with clear communication regarding the role they play in the safe operating procedures and all measures being taken to ensure the safety of their children and themselves.</p> <p>If anyone becomes unwell with the most common symptoms of coronavirus in an education or childcare setting, they must be sent home and advised to follow the COVID-19: Guidance for households with possible coronavirus infection <a href="https://www.gov.uk/government/publications/covid-19-stay-at-home-guidance">https://www.gov.uk/government/publications/covid-19-stay-at-home-guidance</a> Up to date information about the symptoms of coronavirus can also be found here.</p> <p>(Please also see sickness policy addendum).</p> <p>When a child develops symptoms compatible with coronavirus, they should be sent home and advised to self-isolate for 7 days. Their fellow household members should self-isolate for 14 days.</p> <p>Staff and children in all early years' settings are eligible for testing if they become ill with coronavirus symptoms, as will members of their household. A negative test will enable children to return to their childcare setting, and their parents to get back to work. A positive test will ensure rapid action to protect their peers and</p>

	<p>staff in their setting. We will work with staff and families, where testing is required, to arrange for this as soon as possible. Positive tests will be reported to HSE.</p> <p>As per government guidelines, in order to maintain social distancing and keep children in smaller groups with the same staff, we may need to stagger children back to the setting and look at capping numbers. We will communicate all of this to you as part of our nursery return plan and Covid-19 risk assessment. This may involve asking pre-school children to return first as well parents needing to return to work in line with the governments initiatives. If this takes place, we will continue to keep in touch with any children that are staying at home and send out home learning resources. We will continue to communicate with you as government guidelines change.</p> <p><b><i>Information regarding the latest symptom of coronavirus a loss of, or change in, your normal sense of taste or smell (anosmia) –</i></b> It will be very difficult to recognise this symptom in young children and they often go off food and drink for many reasons including when teething. If a child does refuse food/drink at nursery we will inform parents in the usual way and ask them to monitor this alongside any other coronavirus symptoms.</p>
<p><b>Arrivals and departures</b></p>	<p><b><i>Government have recommended where practicable, and safe to do so, that drop off and collection takes place outside of the nursery building. It is paramount that this is done both safely and consistently, to ensure the children’s emotional needs are met. The following should also be considered:</i></b></p> <ul style="list-style-type: none"> <li>• Asking families to have one designated adult to carry out the drop off and collection of their child to minimise the number of adults in the setting. We will work together with you to ensure your child can be welcomed and settled by a familiar adult. This will involve children be dropped off and collected</li> </ul>

	<p>from the main entrance gates at specific times. Children will be met by a staff member and then taken to their room.</p> <ul style="list-style-type: none"> <li>• Key staff will have registers and signing in / out sheets to record arrival and departure times, so attendance can be marked immediately on entry</li> <li>• Only parents who are symptom free and/or have completed the required isolation periods will be able to drop off or collect their child</li> <li>• All parent/carers are asked to follow safe social distancing when dropping and collecting children. There will be safe distancing markings outside of the setting to show these. We will be using cones to mark designated space adhering to the social distancing of two metres</li> <li>• The nursery has changed operating times in line with attendance/ ratios and will therefore be open from 8.30am – 5pm (this will be reviewed fortnightly). Allocated drop of times at the gate to avoid congestion and manage hygiene controls and as well as staff / child ratios will be : Drop off – 8.30am , 9am and 9,30am Collection – 3.30pm, 4pm, 4.30pm, 5pm</li> </ul> <p>Further information will be communicated to all parents in the usual ways prior to the start date.</p> <p>We will also continue to keep you up to date as government guidelines change and we review our practice.</p>
<p><b>Bereavement</b></p>	<p>We recognise that children and their families may have experienced grief and loss of close family members, or friends, during the pandemic. We understand that this is not only a difficult time for families, but it may also be a confusing time for young children, especially if they have little or no understanding of why their parents are upset and why this person is no longer around.</p>

	<p>We have arrangements for parents to contact nursery via email or phone to discuss individual family circumstances and how nursery can be supportive going forward, discussing any bereavements that may have happened during the lockdown period and work with them to support the child the best we can.</p> <p>We will also signpost to other agencies should further support be required.</p>
<p><b>Caring for Babies and Toddlers</b></p>	<p>This policy will continue to be in place with the following additions:</p> <ul style="list-style-type: none"> <li>• Increased frequency of cleaning; toys sterilised after use, any toys/equipment/resources that cannot be easily cleaned e.g. soft toys will not be used during this time</li> <li>• Use of PPE will be used for nappies, toilet accidents etc. Staff required to use PPE will be provided with adequate training.</li> <li>• There will be safe distancing of bed/cots (where possible) and children will be positioned away from each other during sleep times. Bedding and sheets will be washed daily at nursery during the pandemic to avoid germs being transferred from home and nursery.</li> <li>• Items such as towels, flannels and bedding will not be shared by children</li> <li>• Meal times may be staggered to allow for smaller groups</li> <li>• Children will be supervised at all times when eating/drinking to ensure that they do not share cups/utensils or food</li> <li>• Personalised cups will be used to prevent cross contamination</li> <li>• Outdoor shoes removed inside</li> <li>• Parents where possible are asked to limit leaving travel accessories including buggies, car seats, and scooters in the setting.</li> </ul>

<b>Child registration form</b>	Due to households currently being unable to mix we would appreciate if all parents could email the nursery with updated emergency contact details. For example you may currently have nanny as an emergency contact but if nan is vulnerable or showing symptoms this will need to be changed to another family member. Parents responsible for ensuring nursery have these details and any changes are updated. If you emergency develops symptoms nursery also needs to be informed of this as well as an alternative emergency contact.
<b>Incidents</b>	We will continue to follow all government guidelines regarding Covid -19 and keep staff and parents up to date with any changes. This includes following any procedures if the virus spread across the setting and/or the infection rates were to increase again. <b>Early Learning Opportunities Statement</b>	<p>There will be some gaps in children’s assessment records due to the lockdown period. As children settle back in to nursery there will be a strong focus on personal, social and emotional development and re-establishing strong attachments.</p> <p>We will spend time observing and assessing children’s development, working with parents to find out current interests and plan appropriate next steps. To enable us to distinguish children’s next steps the emphasis over the coming weeks will be on getting to know what stages children are working at following the lock down period. You can help nursery by uploading observations from home with details of what you have been doing with your child. This will support the identification of your child’s next steps in learning. The nursery is aiming to establish these by the start of September (Autumn term) where the nursery’s full assessment / planning will</p>

	<p>resume as normal before the lock down period.</p> <p>Children that have not had a two-year old progress check will be planned in due course. All information and reasons for any delays will be documented.</p> <p>Ofsted are currently pausing routine inspections.</p>
<b>Equipment and Resources</b>	<p>We will carry out more frequent cleaning of toys and resources (at least twice daily and where children have explored anything with their mouths). We will have a sterilizing station in the nursery office area where all toys after use will be sterilized before be returned back to the room they can from.</p> <p>Equipment and resources that cannot be easily cleaned, for example soft toys and dressing up, will not be put out during this time. Any unnecessary items in rooms will be stored elsewhere, where possible.</p> <p>Children will be discouraged from bringing items from home into the setting unless it is absolutely essential for their well-being. Where this is the case items should be appropriately cleaned upon arrival.</p>
<b>Health and safety</b>	<p><b>Risk assessment:</b> We will carry out a full risk assessment before opening. This assessment directly addresses risks associated with coronavirus (COVID-19), so that the right measures can be put in place to control those risks for children, their families and staff.</p> <p>We will consult all employees on health and safety, and so they are best placed to understand the risks in nursery.</p> <p>conducted prior to reopening including legionnaires checks.</p>

	<p><b>Social distancing:</b> The early years sector know that unlike older children and adults, babies and young children cannot be expected to remain two metres apart from each other and staff. The government guidelines acknowledges this through advising grouping measures that are in place. Addendums to policies and procedures have been put in place to help minimise the risk of infection through avoiding contact with anyone with symptoms, frequent hand cleaning and good respiratory hygiene practices; regular cleaning of settings, minimising contact and mixing, where possible.</p> <p><b>COSHH assessment:</b> We will ensure that a COSHH assessment is completed for any intended use of bleach and disinfectant products used on site.</p> <p><b>Personal protective equipment (PPE):</b> Government guidance is that PPE is not required for general use in early year’s settings to protect against COVID- 19 transmission. PPE will be continued to be worn as normal for nappy changing and the administration of paediatric first aid as well as mealtimes. PPE will also be worn by staff caring for a sick child while they await collection if a distance of two metres cannot be maintained (such as for a very young child or a child with complex needs.) This includes a specific type of mask and eye shield. Where appropriate staff will be provided with adequate training on the use of PPE.</p> <p><b>Face covering:</b> During everyday practice, staff and children will not be asked to wear face coverings as per the government guidelines.</p> <p><b>Essential supplies:</b> We will ensure an adequate supply of essential supplies by ordering in advance.</p>

	<p>Contingency plans are in place to minimise the impact of any shortages of supplies. The setting will not be not be able to operate without essential supplies required for the management of infection control.</p> <p>A monitoring system for the usage of PPE is essential to ensure that a supply of stock is available to all who require it, as and when required to meet the operational needs of the setting.</p> <p>In case the supply of food is interrupted, procedures will be implemented to ensure appropriate and sufficient food alternatives are sourced, and normal food safety, and hygiene, processes are followed.</p> <p><b>Coronavirus testing:</b> Staff and children in all early years settings are eligible for testing if they become ill with coronavirus symptoms, as will members of their households. A negative test will enable children to return to their childcare setting and their parents to get back to work. A positive test will ensure rapid action to protect their peers and staff in their setting. We will work with staff and families, where testing is required, to arrange for this as soon as possible and ensure isolation periods are followed for all staff and children effected. Infection control	<p><b>We will continue to implement our infection control policy, through maintaining high hygiene standards and reducing the chances of infection being spread.</b></p>

	<p>In addition to this we will:</p> <ul style="list-style-type: none"><li>• Implement robust handwashing routines with extra stations, where possible. Hands will be washed thoroughly for 20 seconds with running water and soap, and dried thoroughly, or use hand foam ensuring that all parts of the hands are covered</li><li>• Clean hands on arrival at the setting, before and after eating, and after sneezing or coughing</li><li>• Encourage staff and, where age/stage appropriate, children not to touch their mouth, eyes and nose (consider face washing with children where appropriate)</li><li>• Ensure good respiratory hygiene - use a tissue or elbow to cough or sneeze and use bins for tissue waste; promoting the 'catch it, bin it, kill it' approach for all staff and children</li><li>• Ensure that help is available for children who have trouble cleaning their hands independently</li><li>• Encourage young children to learn and practise these habits through games, songs and repetition</li><li>• Ensure that lidded bins for tissues are emptied throughout the day</li><li>• Clean frequently touched surfaces often using standard products, such as detergents and bleach (including surfaces that children are touching, such as toys, books, tables, chairs, doors, sinks; wiping down toilets after each use, light switches, bannisters)</li><li>• Where possible, ensure spaces are well ventilated using natural ventilation (opening windows) or ventilation units</li><li>• Take steps to ensure symptomatic individuals do not attend nursery</li><li>• Minimise contact and mixing as much as possible (such as by staggered break/meal times, keeping staff and children in smaller consistent groups, ensuring that the same staff are assigned to each group as far as possible and keep children in the same rooms/areas/outdoor area throughout the day)</li><li>• Ensure play equipment is appropriately cleaned between groups of children using it and that multiple groups do not use it simultaneously.</li></ul>

	<p><b>Children's temperatures</b></p> <p>Routine testing of children's temperatures will not take place as per government guidelines. We remind parents and staff to follow national advice on Covid-19 symptoms. We ask all staff and parents to follow government advice if anyone in their household displays any symptoms.</p> <p><a href="https://www.gov.uk/government/publications/covid-19-stay-at-home-guidance/stay-at-home-guidance-for-households-with-possible-coronavirus-covid-19-infection">https://www.gov.uk/government/publications/covid-19-stay-at-home-guidance/stay-at-home-guidance-for-households-with-possible-coronavirus-covid-19-infection</a></p> <p>Anyone showing signs of coronavirus are advised to not leave their home for at least 7 days and anyone they live with should not leave their home for 14 days. This will be applied for any child, staff or family members accessing nursery.</p> <p>Staff and children in all early years' settings will be eligible for coronavirus testing if they become ill with coronavirus symptoms, as will members of their households. A negative test will enable children to get back to childcare setting, and their parents to get back to work. A positive test will ensure rapid action to protect their peers and staff in their setting.</p> <p>We will work with staff and families where testing is required to arrange for this as soon as possible and ensure isolation periods are followed for all staff and children effected. The child will be cared</p>

	<p>for in a separate room from the other children and the staff member will, in these cases, wear a face covering to minimise the spread of infection.</p> <p><b>Travelling to nursery</b> – Parents, children and young people are encouraged to travel by car, walk or cycle where possible and avoid public transport at peak times.</p>
<b>Intimate Care</b>	<p>We will continue to ensure that all children’s intimate care routines are met following safe practices, as stipulated in the health and safety and infection control policies, including the use of PPE.</p>
<b>Medication</b>	<p>If anyone becomes unwell whilst at nursery, we will contact their parent/carer immediately and they will be sent home. Due to the nature of Covid-19, a key symptom of which is a high temperature, non-prescribed medication will not be administrated unless in emergency situations (with prior permission).</p> <p>Prescribed medication will be reviewed on a case-by-case basis, taking into account the reason for the medication and the safety for the child and member of staff administrating it. For this, online permissions will be requested where possible.</p>
<b>Nutrition and Mealtimes</b>	<p>We are committed to offering children healthy, nutritious and balanced meals and snacks which meet individual needs and requirements, and we will continue to follow this policy. However, due to high demand for delivery slots and some issues with supply, there may be some changes to the set menus on offer. We will communicate any changes to you. We are currently asking parents to provide a packed lunch for the 11am meal time this will be reviewed fortnightly. Nursery will continue to provide breakfast, snacks and tea.</p>





<b>Policy</b>	<b>Addendum required</b>
	<p>Fresh drinking water is always available and accessible, and we will ensure that cups are cleaned after each use and not shared.</p> <p>Meal times may be staggered to allow for smaller groups of children to eat at any one time, this may mean that your child will eat slightly earlier/later than usual. Again any changes will be communicated to you in the usual way. Children will be supervised at all times when eating/drinking, to ensure that they do not share cup/utensils or food. Personalised cups will be used to prevent cross contamination.</p>
<b>Outdoor play</b>	<p>We will be staggering time outdoors to allow for smaller groups of children going out to play at any one time. Children go out with children only in their base room group. We will not be continuing with our activities off premises due to the CO- VID 19 risk.</p> <p>Outdoor equipment will only be used where we are able to ensure that it is appropriately cleaned between groups of children using it, and that multiple groups do not use it simultaneously.</p>
<b>Parents and Carers as</b>	<p>There will be some amendments needed to this policy as we minimise the time parents spend at the nursery. We will communicate via telephone, email and our usual online channels and ask you to do the same to share information about your child. Staff will maintain safe distancing when sharing information about your child's day. We may contact you via phone or email to discuss any other matters rather than face-to-face.</p> <p>We will continue to keep in touch with any families and children not yet returning to nursery, and keep sending through home learning ideas.</p>

	Nursery events/parent evenings will not take place in the nursery during this time and we will keep you updated as government guidelines change.
<b>Parent terms and conditions</b>	<p>There may be some changes made to your terms and conditions and information regarding this will be communicated to you.</p> <p>In particular we would like to draw parent's attention to : If your Child is suffering from a communicable illness, he/she should not be brought to the nursery until such time as the infection has cleared. A full copy of our infection control policy is available from the nursery manager. Please refer to the illness/communicable disease list, supplied in your information, on minimum periods of exclusion from the nursery.</p> <p>This includes the signs and symptoms of Covid-19.</p>
<b>Promoting positive behaviour</b>	The behaviour policy remains in place and will be followed. However, it is acknowledged that children have experienced big changes during this pandemic and this could result in changes to their behaviour. This will be monitored and the policy will be reviewed in line with this, where required.
<b>Quality of provision</b>	The Early Years Foundation Stage (EYFS) sets the standards that schools and childcare settings must meet for the learning, development and care of children from birth to 5 years old. We will use reasonable endeavours to deliver the learning and development requirements, as far as possible, in the current circumstances and ensure we follow the Early Years Foundation Stage: Coronavirus Disapplication's where required. 	<p>The long end date of the legislative changes is shown in the regulations as 25 September 2020, but these will be reviewed on a monthly basis and disapplication, and modifications, may be lifted earlier. For instance, if government advice on self-isolation and social distancing is amended.</p> <p>As part of our quality practice, we will carry out more frequent cleaning of toys and resources (at least twice daily and if children have put these in their mouths.)</p> <p>We still want to provide children with a wide range of activities and experiences, however some of these may differ to minimise the spread of germs, for example playdough, sand and water play. This may need to be presented in an individual tray and discarded afterwards, rather than all children accessing them at the same time.</p>
<p><b>Safe and healthy nursery</b></p>	<p><b>We will follow our safe and healthy nursery policy with the following additional procedures:</b></p> <p><b>Personal hygiene:</b> Staff are reminded to ensure personal hygiene at all times, including washing hands as they enter the building and periodically throughout the day (see infection control policy addendum.)</p> <p><b>Cleaning:</b> Staff are asked to support the continued cleaning of the nursery throughout the day e.g. toilets, wiping light switches, kitchen areas.</p> <p><b>Staff breaks:</b> All staff breaks will be staggered to minimise the number staff in the staff room at one time and ensure social distancing. Staff are encouraged to stay in at break times, where possible.</p> <p><b>Use of offices:</b> Staff will be asked to stagger the use of the office to limit occupancy. All equipment e.g. mouse and keyboards, are to be cleaned after each use.</p> <p><b>Staff equipment:</b> Equipment used by staff such as stationary, tablets etc. will be allocated to individual staff</p>

	<p>members, where possible, and cleaned regularly.</p> <p><b>Uniform:</b> Staff are asked to wear a clean uniform each day.</p> <p><b>Travelling to work:</b> Staff are encouraged to drive alone, walk or cycle to work and avoid public transport at peak times, where possible. We will advise staff of the guidance on precautionary measures to be taken when travelling using public transport.</p> <p><b>Essential supplies:</b> We will ensure an adequate supply of essential supplies by ordering in advance and have contingency plans in place to minimise the impact of any shortages of supplies. The setting will not be able to operate without essential supplies required for ensuring infection control.</p>
<p><b>Safe and respectful care</b></p>	<p>We will continue to follow this procedure with the exception of when a child is ill. We will follow the sickness and illness addendum, which advises to care for the child in an isolated room with the door closed, where possible. This will still be in line with our safeguarding policy.</p>

<p><b>Settling In (Prospective Parents)</b></p>	<p>Setting visits may be planned based on individual needs, taking in to account the age/stage of development            Where settling visits are required, different options will be considered such as:</p> <ul style="list-style-type: none"> <li>• Whilst the nursery is still closed, so there are no other children/adults around</li> <li>• Having a settling in period over a couple of weeks just for visits to take place</li> <li>• Shorter sessions to begin with building up to the full session</li> </ul>

	<p>The settling in policy for new children will be adapted during the pandemic based on the individual needs of the children and staff at nursery. We may have to suspend these or, where possible, we will encourage virtual show rounds prior to children starting. Most of the information will be gathered over the telephone to limit the time spent in the setting and registration forms will be taken home to be completed and an appointment made to return these.</p> <p>Any new families will be asked to sign a health declaration to confirm the child or no one in the family has any symptoms of coronavirus.</p> <p>Once children are settled parents will be asked to follow the same drop off/collection procedures as the other children, maintaining safe distancing between them and others (see arrival and departure policy.)</p>
<b>Sickness and Illness</b>	<p>If anyone becomes unwell whilst at nursery with a new, continuous cough or a high temperature, we will contact their parent/carer immediately. The child will be sent home and advised to follow the COVID-19: Guidance for households with possible coronavirus infection.</p> <p>Whilst the child is awaiting collection they will be moved, if possible, to a room where they can be isolated behind a closed door, depending on the age of the child, and with appropriate adult supervision (ensuring safeguarding and PPE procedures are met.)</p> <p>Ideally, a window will be opened for ventilation. Where it is not possible to isolate them, they will be moved to an area away from other children and adults.</p>

	<p>They will be comforted and reassured whilst waiting for collection, as per our usual policy.</p> <p>If they need to go to the bathroom while waiting to be collected, they will use a separate bathroom. The bathroom will be cleaned and disinfected, using standard cleaning products, before being used by anyone else.</p> <p>PPE will be worn by staff caring for the child while they await collection if a distance of two metres cannot be maintained (such as for a very young child or a child with complex needs.)</p> <p>In an emergency staff will call a manager and 999 if they are seriously ill, injured or their life is at risk.</p> <p>If a member of staff has helped someone who was unwell with a new, continuous cough or a high temperature, they do not need to go home unless they develop symptoms themselves (and in which case, a test is available) or the child subsequently tests positive (see ‘What happens if there is a confirmed case of coronavirus in a setting?’ below.) They should wash their hands thoroughly for 20 seconds after any contact with someone who is unwell.</p> <p>Cleaning the affected area with normal household disinfectant after someone with symptoms has left, will reduce the risk of passing the infection on to other people. Their fellow household members should self-isolate for 14</p>

All staff and students who are attending an education or childcare setting will have access to a test if they display symptoms of coronavirus, and are encouraged to get tested in this scenario.</p> <p>Where the child or staff member tests negative, they can return to their setting and the fellow household members can end their self-isolation.</p> <p>Where the child, young person or staff member tests positive, the rest of their nursery group (this includes the children in their base room and staff) should be sent home and advised to self-isolate for 14 days. The other household members of that group do not need to self-isolate unless the child, young person or staff member they live with in that group subsequently develops symptoms.</p> <p>In these cases all information will be recorded on an incident form or Covid-19 record form</p>
<p><b>Special Educational Needs and Disabilities (SEND)</b></p>	<p>Vulnerable children continue to be expected and encouraged to attend educational provision where it is appropriate for them to do so (for children with education health and care (EHC) plans this will be informed by a risk assessment approach.)</p> <p>Children, young people and staff who have been classed as clinically extremely vulnerable due to pre-existing medical conditions, have been advised to shield and are not expected to attend nursery. They should continue to be supported to learn at home, as much as possible.</p> <p>Due to the lockdown and as per the Early Years Foundation Stage: coronavirus disapplications adjustment, the EYFS two-year-old progress check requirement may mean that some progress checks are delayed. These will</p>

	<p>take place as soon as is reasonably practical and any areas where a child's progress is less than expected, we will put a plan in place with activities and strategies to address any concerns.</p> <p>Assessment for all children will take place gradually over the next few months with a strong focus on re-settling children. Strategies and support will be put in place for any children with noticeable gaps in development progress.</p>
<b>Staff development and Training</b>	<p>The training records of all staff members will be checked and any expired mandatory training that is required (including safeguarding, paediatric first aid, food hygiene) will be planned as soon as possible. Prior to returning back to nursery following furlough all staff members will be required to complete the control and infection and illness course to further support their practice.</p> <p>Where possible, meetings and training sessions should be conducted online.</p> <p>All staff members will receive appropriate instructions, and training, in the policy and procedure addendums; infection control, the standard operating procedures and risk assessments within which they will be operating.</p>
<b>Supervisions</b>	<p>Staff will all have a supervision/review meeting prior to returning to work, this may take place over the phone or at the setting where social distancing can be applied. Nursery will informally keep in touch with all staff as a cohort using the nursery Watts App group.</p> <p>Regular supervision/review meetings will then take place to monitor staff well-being and any concerns during this time.</p>

<b>Supervision of Visitors</b>	<p>Attendance to the setting will be restricted to children and staff where practicable.</p> <p>Visitors will only be allowed to enter where prior permission has been granted and that they are not displaying any symptoms of coronavirus. They will be asked to sign a declaration form. The supervision of visitor's policy will be followed in these cases.</p> <p>Suppliers such as food deliveries will be asked not to enter the nursery but to make other arrangements, for example to ring the bell and leave the delivery at the door.</p> <p>Where essential visitors e.g. building maintenance, are required these will be made outside of the usual nursery operational hours where possible.</p>
<b>Transition</b>	<p><b>Moving rooms:</b> Where possible children will return back to their normal room, however due to the CO-VID 19 and risk assessment nursery has needed to make some changes in regards to the rooms children will be in and these will become base rooms rather than class rooms. Children will however have a key person from their original room or where this is not possible and member of staff they are previously familiar with. Parents will be informed of who their child's key person will be and which room will be there base room.</p> <p><b>For any children going to school:</b> We will work together with all schools that children are going to and attempt to do all we can to help ease this transition, including making up school packs with photos of the teachers and building; reading stories as well as engaging in activities such as role play. We will also work with parents to try to alleviate any worries and anxieties. All parents need to inform nursery of the school their child will be attending.</p>

<p><b>Visits and outings</b></p>	<p>To help ensure the safety of staff and children no external visits and outings from the nursery setting will take place during this pandemic. This will be reviewed in line with government guidelines.</p>
<p><b>Volunteers / Students from further education</b></p>	<p>Although we appreciate the support and value volunteers / students offer to our nursery, we have decided that during the pandemic period we will not be permitting volunteers / students in the nursery to care and support the children at this time. This is because we are trying to limit the number of people in nursery at any one time. We will review this in line with Government policy and updates, and review accordingly.</p>
<p><b>Well-being in the nursery</b></p>	<p>Children are supported in age appropriate ways to understand the steps they can take to keep themselves safe including regular hand washing and sneezing into a tissue. Staff will help them to understand the changes and challenges they may have/be encountering as a result of Covid-19 through play, discussions and stories.</p> <p>Staff are aware of the importance of attachments and that some children may experience separation anxieties during this time. They will work with parents to ensure they help to ease the transition back to nursery and give children the emotional support they need at this time.</p> <p>Please also refer to the bereavement policy.</p>
<p><b>Well-being for staff</b></p>	<p>Managers are very conscious of the well-being of all staff during the pandemic and now the worries as they return to caring for children. Regular meetings/supervisions will be planned to support staff. Discussions will take place around the need for flexible working practices in a way that promotes good work-life balance and supports the nursery business.</p>

	<p>Having a good communication policy and, sharing plans and risk assessments will help to manage anxieties about returning to work. Staff workloads will be carefully managed during this time with the emphasis on playing with the children; settling them back in, offering lots of support and reassurance.</p>
